"I Told You, Buddy!"

We have a special time in our house when everything stops as we watch the game shows - *Jeopardy* and *Wheel of Fortune*! It seems like our entire day of entertainment revolves around 3:30 and 6:30 pm! The other afternoon, our resident teacher, a.k.a. Monique, offered unsolicited advice to one of the *Jeopardy* contestants who had quickly responded to the clue, "What is gnash?" (as in gnashing of teeth!).



The contestant was surprised when the host, Ken Jennings, told him "No. I'm sorry!" Immediately, Monique couldn't hold back and began shouting aloud, "Gnashed! Gnashed!" in the past tense to correct him. While the frustrated man was surely "gnashing his teeth" with disappointment, Monique blurted out her game-show counsel one final time, "I told you, buddy! But you wouldn't listen to me!"

Many times, in recorded Scripture, you will read about how God rebuked and warned His children, "I told you, but you wouldn't listen to me!" Depending on your translation, the number of Bible references for the word "listen" or "hear" varies between 265 (ESV) and 550 (KJV) times. God often reminds us in His Word to listen, pay close attention, give ear, hearken and obey His instruction.

We need to revisit the story of how Eli, the priest, advised young Samuel to simply reply to God's promptings in this way, "Speak, Lord, your servant is listening." (1 Samuel 3:1-10). I don't think any of us want to hear God's scolding, "I told you... but you wouldn't listen!" Sometime during these beautiful spring days, try to go out in nature or find that special place and time for quiet reflection. Make this your opening prayer, "Speak, Lord. I'm listening."
